Subject : Low Sulphur Surcharge (LSS) Implementation

Dear Valued HEUNG A LINE Customers,

Based on the new regulation of International Maritime Organization (IMO) regarding the Sulphur limit of 0.5% which will be applied from Jan 1st. 2020, We HEUNG A LINE has decided to apply a new surcharge (LSS) in order to recover the increasing bunker cost. The additional charge will be used for all our vessels to comply with the new regulation and cover other operational aspects.

In addition to the above, we have decided to update the LSS rate **effective from January 1st, 2026**, to match the changes in bunker costs.
